## REGULATIONS

**Art. 1** The competition is open to all dance schools, associations, and gyms. Dancers of any nationality may participate.

**Art. 2** The competition will host the following categories:

- Small Dancers: 3 to 5 years old
- Baby Plus: 6 to 8 years old
- Baby: 9 to 11 years old
- Allievi: 12 to 13 years old
- Junior: 14 to 16 years old
- Out-of-quota participants are allowed up to 20%.

**Art. 3** All choreographers must complete the registration form at [www.eventidanzasicilia.com](http://www.eventidanzasicilia.com).

The choreography fees are as follows:

- Groups: €170 (€120 with scholarship, minimum 4 members)
- Soloists: €85 (€60 with scholarship)
- Second Soloist Choreography: €70
- Duets: €125 (€85 with scholarship)
- Second Duet Choreography and beyond: €75
- Latin and Caribbean Soloists: €35
- Second Latin and Caribbean Solo Choreography: €30
- Latin and Caribbean Duets: €35 per person
- Second Latin and Caribbean Duet Choreography: €35 per person
- Entrance fee for accompanying persons (ages 6 and up): €6

**Art. 4** The competition will take place at **TEATRO CITTÀ DELLA NOTTE AUGUSTA**, Saturday, March 15, at **9:00 a.m.** (Please confirm the schedule with the organization at least one week in advance).

**Art. 5** The following dance styles are allowed:

- Classical/Neoclassical
- Modern and Jazz
- Contemporary
- Hip Hop
- Latin and Caribbean
- Choreographic Idea (includes disciplines not listed above, e.g., fusion, musical, tap dance, flamenco, etc.).

**Art. 6** Each dancer in the soloist category may perform twice in the same dance style.

**Art. 8** Performance durations:

- Groups: 3 minutes 30 seconds
- Soloists: 2 minutes
- Duets: 2 minutes 30 seconds

Exceeding the time limit will result in a 2-point penalty.

**Art. 9** Music must be provided on a USB drive and handed to the technical team by a group representative during check-in at the secretary's desk.

If the music is not ready at the time of performance, the schedule will proceed as planned.

**Art. 10** Props used during performances must be set up and removed within a maximum of 10 seconds each. Exceeding this limit will result in a 2-point penalty.

The use of materials that could dirty or make the stage slippery (e.g., paint, water, confetti) is prohibited.

**Art. 11** At the end of the competition, prizes and scholarships will be awarded.

**Art. 12** The organization assumes no responsibility for damages to persons or property during the event, whether caused or suffered by participants.

**Art. 13** For the success of the event, the organization reserves the right to modify, replace, remove, or add articles to these regulations, both in print and online. Program changes may be made at any time for organizational needs.

**Art. 14** In compliance with Italian law (L. 31/12/96 N. 675 and D.LGS N.196 of 30/06/2003), by accepting these regulations, participants authorize ASD EVENTI DANZA APS ETS to process personal data for purposes related to the competition. This includes the use of images, video, and audio recordings for promoting cultural and sports initiatives, without any form of compensation. These documents must be available upon request and should be valid at the time of the event.

**Art. 18** By registering for the event, participants agree to abide by these regulations in their entirety, acknowledge the association's statute, and release its directors from liability for the use of social structures.
